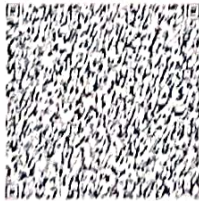

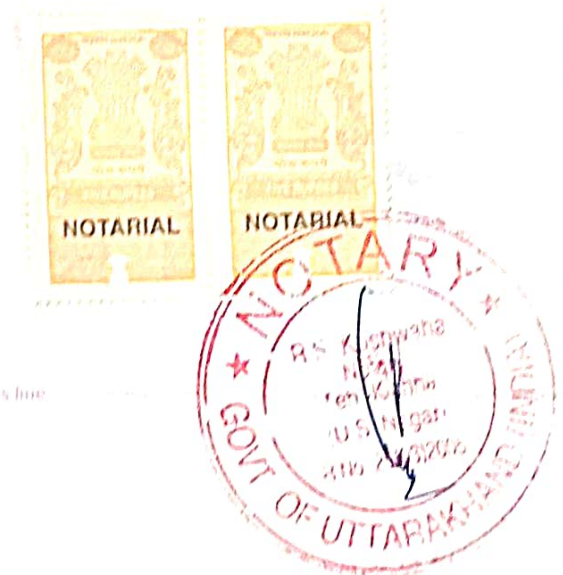

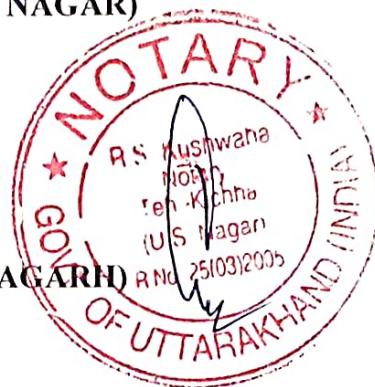

2.4 Entrepreneurial Ventures: The agreement supports the design and implementation of programs focused on promoting entrepreneurial skills, including mentorship opportunities, business competitions, and innovation workshops.

2.5 Professional Development for Faculty and Staff: The MOU encompasses initiatives aimed at the continuous professional development of teachers, ensuring they remain adept at addressing evolving educational demands and fostering an environment of lifelong learning.

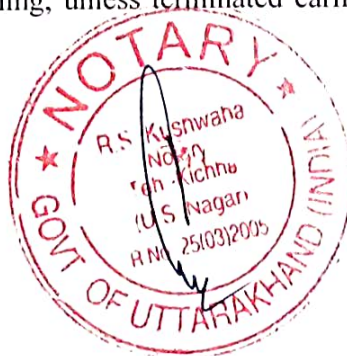

This Memorandum of Understanding (MOU) is hereby accepted and agreed upon by the undersigned parties, signifying their commitment to the terms set forth herein.

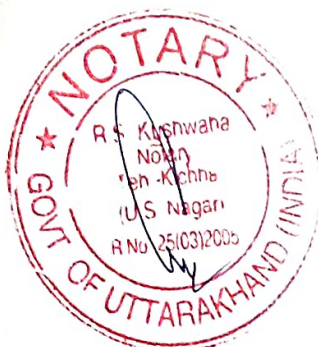
